

North American International Livestock Exposition Show Information

UPDATE LOG

- October 30, 2020
 - Overnight in-building camping and light cooking is limited to only Dairy Cattle exhibitors. The limitation of in-building camping is due to the increased COVID-19 cases in the United States. Participants that are showing other livestock need to seek accommodations through neighboring hotel/motel and RV camping. - October 1st. 2020
 - o Tents with roofs are prohibited as they are a greater fire hazard.
 - Added clarity in the Pre-Arrival Information section regarding those driving through the state with positivity rates at or above 15%. We also provided information about refunds.
 - Added an Additional Questions section with questions and answers.
 - Updated the Show Schedule section to have the new deadline of October 10th with no late fees.

COVID-19 RESPONSE PLAN HIGHLIGHTS

- North American International Livestock Exposition has implemented a plan in response to COVID-19 to limit the spread of the virus. The COVID-19 plan includes but is not limited to these elements:
 - PARTICIPANT-ONLY SHOW The North American International Livestock
 Exposition will close to the general public, allowing easier contact tracing and
 also provide the greatest reduction in the spread of COVID-19. Building Access
 Badges are required to enter the buildings and barn areas. Event Passes only
 allow you to enter the parking lot and exterior areas of the facility.
 - INCREASED HYGIENE ACCESSIBILITY Hand sanitizer and handwashing stations will be available throughout the property.

- MASKS REQUIRED Masks will be required to be worn by everyone on property. Especially when social distancing is not achievable. This applies for indoor and outdoor areas.
- SCHEDULE CHANGES The 2020 North American Championship Rodeo and Country Store, and awards banquets associated with competitions have been cancelled. Saddle and Sirloin Club will be virtual this year. Additional Schedule changes have been made so please check the livestock and equine online schedules.
- WIDER AISLE WAYS Aisles inside the facility will be widened and some identified as one-way aisles.

PRE-ARRIVAL INFORMATION

Participants will not be allowed to enter the facility unless they can attest (with a written, signed document) that they have not been to a state that has a COVID-19 positivity rate equal to or greater than 15% 14 days prior to the date of their scheduled arrival time. Participants who are from a state equal to or greater than 15% 14 days prior to their scheduled arrival time that can attest to quarantining for 14 days will be allowed to participate in the show. This document will be sent to participants and also available at the check-in process.

We will utilize the updated numbers provided by John Hopkins University and Medicine (https://coronavirus.jhu.edu/testing/testing-positivity).

- Participants can drive through states that are at or greater than 15% and will be allowed to enter.
- Refunds will be given to exhibitors from states with a 15% positivity rate.
- Exhibitors who cannot attest via the sign waiver at check-in will have an option of being refunded.

GATE INFORMATION

- The Main Entrance (Gate 1) will be open throughout the show and is at the intersection of Freedom Way and Phillips Lane.
- The Kentucky Exposition Center is located at 937 Phillips Ln. Louisville Kent

CHECK-IN PROCESS

Before accessing the property, all participants must check-in at Lot V, adjacent to the Main Entrance (Gate 1). Check-in runs 24/7 November 2-17.

- There is a 3-step system to checking in this year. First, Animal health screenings will be conducted.
 - Please make sure you have all necessary papers showing proof of animal health.

- Second, Participants will be required to complete or provide their COVID-19 waiver
 affirming they are in good health. Contact information will be collected and a wristband
 will be given to all participants and helpers. You must keep this wristband on throughout
 the event. The wristband does NOT permit you inside the building. A building access
 badge is required to enter the building.
 - We collect contact information in order to perform necessary contact tracing. This
 is in compliance with Kentucky's Healthy at Work Initiative guidelines for our
 show.
- Third, You will then receive appropriate credentialing to access the property and building in the form of pre-purchased event passes and building access badges.
 - Event Passes are color coded and are scanned at the gate, covering the daily cost for parking and admission. Event passes do not allow you to access the building but so allow you to park and walk to outside areas around the facility.
 - Building Access Badges are color-coded and limited based on the head of livestock you are bringing to the show. They are associated with your barn registration. Building access badges must be worn by every person within the building. Without a building access badge, you are prohibited from entering the building and barn areas.
 - Small Animals (including: sheep, goat, swine)
 - Participants with 1-5 head of livestock will receive 3 badges.
 - Participants with 6-10 head of livestock will receive 4 badges.
 - Participants with 11-15 head of livestock will receive 5 badges.
 - Participants with 16+ head of livestock will receive 6 badges.
 - Large Animals (including: beef and dairy cattle)
 - Participants with 1-5 head of livestock will receive 3 badges.
 - Participants with 6-10 head of livestock will receive 5 badges.
 - Participants with 11-15 head of livestock will receive 7 badges.
 - Participants with 16+ head of livestock will receive 8 badges.

ENTERING THE PROPERTY AND BUILDINGS

Access to 2020 NAILE is restricted and will require a series of necessary credentials to enter. Please read below for additional details.

- Health Waiver Wristbands are to be worn by all those in attendance to confirm the COVID-19 health waiver has been submitted and received by Kentucky Venues.
- Event Passes are color coded and are scanned at the gate, covering the daily cost for parking and admission. Event passes <u>do not allow you to access the building</u> but so allow you to park and walk to outside areas around the facility.
- Building Access Badges are color coded and limited based on the head of livestock you
 are bringing to the show. Building access badges must be worn by every person within
 the building. Without a building access badge, you are prohibited from entering the
 building and barn areas.

Parking and Outdoor Areas

To enter the property you must have your **Health Waiver Wristband** provided at check-in and you must have an **Event Pass**. If you have lost your wristband, you can complete another waiver at the Ticket Office adjacent to Freedom Hall. Ticket Office Hours are Monday-Friday 10am-5pm. If you do not have an event pass, you can purchase one at the Main Entrance. Otherwise, admission is \$8 and parking is \$10.

- Event Pass 1 is valid from November 2-10 and is \$35
- Event Pass 2 is valid from November 11-19 and is \$35
- Full Event Pass is valid from November 2-29 and is \$60

Buildings, Barns, Parking and Outdoor Areas

To enter the property and indoor buildings you must have your **Health Waiver Wristband** provided at check-in, **Event Pass** and your **Building Access Badge**. If you have lost your wristband, you can complete another waiver at the Ticket Office adjacent to Freedom Hall. Ticket Office Hours are Monday-Friday 10am-5pm. If you do not have an event pass, you can purchase one at the main entrance.

- Event Pass 1 is valid from November 2-10 and is \$35.
- Event Pass 2 is valid from November 11-19 and is \$35.
- Full Event Pass is valid from November 2-29 and is \$60.
- Admission without an event pass is \$8 and parking is \$10.

You must present a **Building Access Badge**, provided to you at check-in, to enter the building. Building Access badges are provided to exhibitors for those supporting and exhibiting their livestock. They are associated with the barn registration. You cannot enter the building without this badge.

BUILDING ACCESS BADGES

Due to specific species requiring additional support, participants will be required to have a Building Access Badge to access buildings.

Small Animals (including: sheep, goat, swine)

- Participants with 1-5 head of livestock will receive 3 badges.
- Participants with 6-10 head of livestock will receive 4 badges.
- Participants with 11-15 head of livestock will receive 5 badges.
- Participants with 16+ head of livestock will receive 6 badges.

Large Animals (including: beef and dairy cattle)

- Participants with 1-5 head of livestock will receive 3 badges.
- Participants with 6-10 head of livestock will receive 5 badges.
- Participants with 11-15 head of livestock will receive 7 badges.
- Participants with 16+ head of livestock will receive 8 badges.

SHOW SCHEDULE

 - The Livestock Show is November 2-19
 - Entries are due October 10 with no late fees.
 - The livestock schedule presents the arrival and show schedule of dairy cattle, dairy goats, swine, breeding sheep, market lambs/commercial ewes, boer goats, market goats/wether dams and beef cattle.

OVERNIGHT IN-BUILDING CAMPING, RV PARKING & COOKING

- Overnight in-building camping and light cooking is limited to only Dairy Cattle exhibitors.
 The limitation of in-building camping is due to the increased COVID cases in the United States. Participants that are showing other livestock need to seek accommodations through neighboring hotel/motel and RV camping.

- RV camping is available by reservation at Lot L after entering the main entrance Please call (502) 367-5380 to reserve your space. For additional details view this <u>document</u>.
 - Electric camping is limited and is \$75 a night and guarantees 20/30 amp service.
 50 amp is offered on a first come, first serve basis.
 - Dry camping (no electrical, water sewer hookups) is \$50 a night.
 - A non-refundable deposit covers your first night's stay.
- Equipment brought to prepare food is not allowed. No food or beverage of any kind is permitted to be brought into the venue by the patron or patron's guests.
- Credentialing is required by all those camping on-site. Call 502) 367-5380 to reserve your space and receive credentialing.

TACK SHOPS AND FOOD VENDORS

• Will be spread throughout the property. The North American Marketplace/Country Store will return in 2021.

FIRST AID

• First aid locations will be at West Hall, North Wing in the Freedom Hall Coliseum. The coliseum location is staffed 24/7 throughout the show.

ADDITIONAL QUESTIONS/ANSWERS

When is the Entry Deadline?

• Entry Deadline has been moved to October 10th with no late fees.

Can I get a refund if I am unable to attest that I am from a state that has a 15% or more positivity rate?

A full refund will be issued to exhibitors who cannot sign the waiver because they
are from a state with a 15% or higher positivity rate, are exhibiting COVID-19
symptoms and/or did not quarantine for 14 days prior to attending the show.
Participants who are from a state equal to or greater than 15% 14 days prior to
their scheduled arrival time that can attest to quarantining for 14 days will be
allowed to participate in the show.

What is an Event Pass?

- An Event Pass covers admission and parking to enter the facility. They allow you
 to access outside areas of the property but **DO NOT** allow you to enter indoor
 areas like the facility. There are three types of event passes:
 - Event Pass 1 is valid from November 2-10 and is \$35.
 - Event Pass 2 is valid from November 11-19 and is \$35.
 - Full Event Pass is valid from November 2-29 and is \$60.

What is a Building Access Badge?

 Building Access Badges are determined based on the head of livestock entered and the size of that livestock. They are associated with the barn and are transferable amongst exhibitors working for the same barn. You need an Event Pass to enter the property and a building access badge to enter the buildings. Here is the breakdown of the quantity of badges provided. These are given to you at check-in.

Small Animals (including: sheep, goat, swine)

o Participants with 1-5 head of livestock will receive 3 badges.

- o Participants with 6-10 head of livestock will receive 4 badges.
- Participants with 11-15 head of livestock will receive 5 badges.
- Participants with 16+ head of livestock will receive 6 badges.

Large Animals (including: beef and dairy cattle)

- o Participants with 1-5 head of livestock will receive 3 badges.
- Participants with 6-10 head of livestock will receive 5 badges.
- o Participants with 11-15 head of livestock will receive 7 badges.
- o Participants with 16+ head of livestock will receive 8 badges.
